## **Your Opportunity**

As part of a small IT function and reporting to the Manager – IT, the role of Systems Security Officer is to develop, implement and continually enhance IT-related security policies, processes and tools which protect the organisation's information assets, including infrastructure, networks and data.

Key aspects of the role include:

- Developing and maintaining fit-for-purpose security-related processes, architecture and guidelines compliant with APRA, ITIL and internal policies developed based on best practice.
- Proactively monitoring technology and information assets to minimise the risk of breaches, and implement fixes where vulnerabilities and / or threats are identified.
- Effectively resolving security issues and incidents, identifying and applying fixes, and reporting incidents / issues to relevant stakeholders.
- Making recommendations to the business, and implement as agreed, appropriate tools and services to protect information assets across internal, vendor and core banking systems, and through other integration services.
- Providing input on information security requirements as part of business improvement and other project activities.
- Conducting regular system audits to ensure the robustness of the information security framework, including user access.
- · Supporting DR and BCP activities, and take an active role in PEN testing and remediation.

The position operates within a small IT function. As such, there is an ongoing requirement to provide general IT support across the business as needed. Aspects of IT support include but are not limited to the core banking system operations, systems and software upgrades, user access and equipment requirements.

#### **Your Profile**

Working organisation-wide as part of a small IT team, you demonstrate excellent interpersonal skills and a service-oriented demeanour. You have the capacity to work independently and just as effectively in a team environment.

Your sound judgement ensures you provide well-considered and timely recommendations on matters within your area of expertise.
